Subject: Oconomowoc Perishable DC Transition from Roundy's EDI to Kroger EDI

You are receiving this notice because your company has been identified as delivering **perishable** items to the Oconomowoc DC.

WHAT IS HAPPENING?

Beginning October 6, all perishable items delivered to the Roundy's Oconomowoc DC will be ordered from the Kroger OLP (On-Line Purchasing) system.

Perishable Purchase Orders <u>delivered to Oconomowoc after October 6, 2018</u>, will be written on the Kroger OLP system and transmitted by Kroger EDI. Perishable Purchase Orders <u>delivered to</u> <u>Oconomowoc prior to October 6, 2018</u>, will be written on the Roundy's procurement system and transmitted by Roundy's EDI.

<u>As early as October 6, 2018</u>, the Perishable Purchase Orders could be created on the Kroger OLP system and transmitted by Kroger EDI. Please update your company's appropriate systems to receive Perishable Oconomowoc orders from Kroger EDI.

- Please be aware the mapping specifications will change from Roundy's format to the Kroger format for all EDI transactions exchanged. Please review the Kroger Implementation guides by clicking here.
- On your EDI and downstream systems, please setup the new Roundy's 'Ship-To' and 'Bill-To' DUNS numbers.

If You Are an *Existing* Kroger EDI Trading Partner:

- Expect to receive EDI Purchase Orders for the Oconomowoc DC as early as October 6, 2018, for deliveries after October 6, 2018. The EDI PO's will transmit from Kroger EDI ISA/QAL: 9254110060/08 and GS ID of 5137624388 listing the same standard and version as other Kroger DC PO's and invoices sent to your company.
- If your company exchanges 850 Purchase Orders and 810 invoices with Kroger, then the Oconomowoc orders/invoices will be 850/810 (Standards: X12 and version 005010). If your company exchanges 875 Purchase Orders and 880 invoices with Kroger, then the Oconomowoc orders/invoices will be 875/880 (Standards: UCS and version 005010UCS).
- Once you begin receiving the EDI PO's from Kroger EDI, EDI invoices MUST be sent BACK to Kroger EDI.
- It is imperative you use your existing Kroger EDI partnership to exchange transactions for the Oconomowoc perishable items ordered from the Kroger OLP system.
- All invoices with delivery dates of October 6, 2018 or later must be transmitted to Kroger EDI with the new Ship-To and Bill-To DUNS numbers. Failure to prepare your systems may impact or jeopardize invoice processing and payment.
- Please direct questions regarding items and vendors to the Roundy's buyer(s) or category manager.

If You Are *New* Kroger EDI Trading Partner:

- All suppliers who are new to Kroger must establish an EDI relationship with Kroger's EDI system before EDI Purchase Orders can be transmitted from Kroger EDI to your company.
- If you deliver frozen items to the Oconomowoc DC, but are NOT currently exchanging EDI documents with Kroger's EDI ISA/QAL: 9254110060/08, please submit a 'New Partner Setup Form' at our EDI website by clicking <u>here</u>.
